BBB SCAM TRACKER UPGRADE: BBB SCAM TRACKER IS AN ONLINE TOOL THAT ENABLES CONSUMERS TO REPORT SCAM ACTIVITY. IN 2022, BBB INSTITUTE PARTNERED WITH AMAZON AND CAPITAL ONE TO REBUILD THE PLATFORM. THE NEW PLATFORM IS MORE INTUITIVE FOR USERS AND NOW INCLUDES AN ADVANCED SEARCH FUNCTION TO HELP PEOPLE SEARCH BY URL, EMAIL, PHONE NUMBER, AND MORE TO DETERMINE IF THEY'RE BEING TARGETED. SINCE THE LAUNCH, SUBMITTED REPORTS INCREASED 58 PERCENT AND TRAFFIC INCREASED 105 PERCENT (YEAR OVER YEAR).
